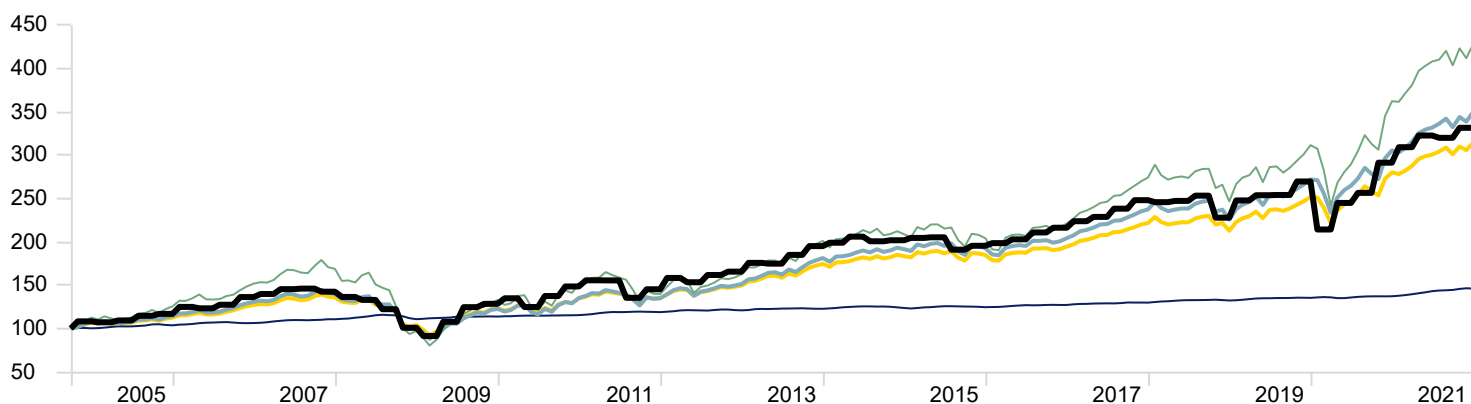

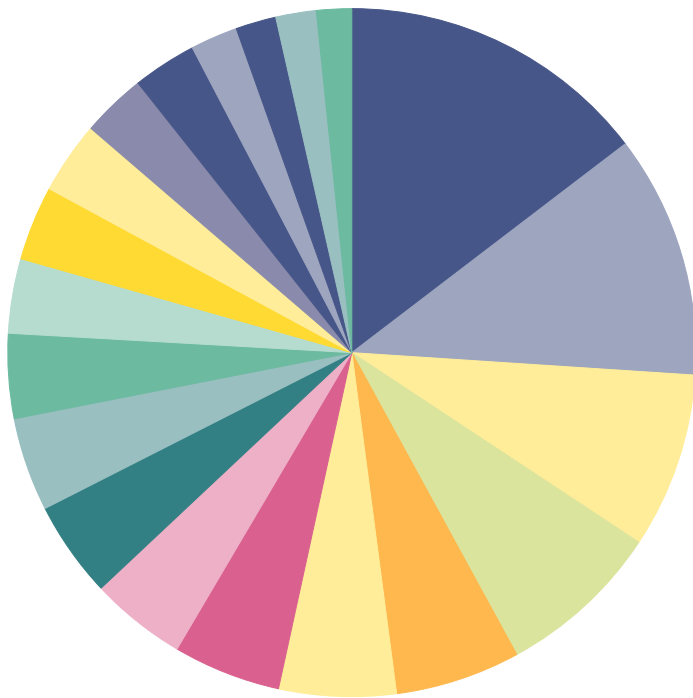
### Investment Growth of \$100 Since 9/30/2004
